

## **Information note on cookies**

The use of the website [www.giorgiopressburger.eu](http://www.giorgiopressburger.eu) involves the sending of cookies and similar devices to the user's computer.

For this reason, with this document, Associazione Culturale Giorgio Pressburger. (head office: Trieste, via del Carpineto 31, 34148, Italia), Data manager provides information to users of the website about the cookies used and similar systems that are allowed to be installed.

### **What are the cookies?**

Cookies are small-size data files sent by the user-visited websites to the user's computer (usually to the browser) where they become saved, to be resent to the same websites later on during the next browsing activity of the same user.

We distinguish between session cookies (used solely for the purpose of transmitting the communication to an electronic communications network or within strictly prescribed limits, exclusively to the person providing the service requested), performance cookies (designed to create user profiles and used to send advertising messages via the Internet according to the preferences shown by the user during the visits).

During the visit, the user's computer may also receive cookies sent by other websites or web servers (see also third-party "cookies") and which are set up by the operators of those websites, and are used for the purposes and in the way specified by such persons.

### **The type of cookies used on this website**

The website uses third-party session cookies and performance cookies.

#### **Session cookies**

Requesting permission is not mandatory for session cookies. They are small, temporarily stored information designed to support search and the use of websites.

#### **Third-party performance cookies**

At [www.giorgiopressburger.eu](http://www.giorgiopressburger.eu), some cookies generated by third parties and performance cookies have been installed which become activated by clicking on the "OK" button in the browser or track the visitor during browsing by scrolling.

Below is a detailed description of the third-party cookies and the links through which the user can receive more information or request the deactivation of cookies.

### Google Analytics

The website uses Google Analytics. This is a web analytics service provided by Google Inc. ("Google"). It uses the cookies installed on the user's computer to allow for statistical analyses of the use of the website visited, in an aggregate form.

Data generated by Google Analytics also through the use of the IP addresses of the user will be retained by Google as indicated in the Information Note available at the following link:

## Google AdWords

These are cookies with the function that allows the user to search according to specific criteria (e.g. language, products selected for purchase), with the aim of improving the services provided by the website and to suggest Google-managed contents to the client.

## Social Buttons

Social Buttons are special “buttons” that appear on the website and represent the icons of social networking sites (e.g. Facebook and X), allowing for users to go directly to the social networking site by clicking on the button.

## Installation of cookies

With the exception of session cookies, for the installation of the other cookies and other similar devices, the permission of the website user is required after they have read the brief notice on the banner.

The user may prevent the installation of third-party cookies by keeping the banner opened (not closing it by clicking on the “OK” button or not continuing with the browsing activity), or by using the settings available in their own search engine.

We draw the attention of users who visit the website from a mobile phone to the fact that the system configurations that exclude the storage of cookies or ensure their deletion vary depending on the brand and / or model of the device used, so please read the instructions given by the manufacturer.
